My name is Laurent Amoussan the only surviving son of the late Dr Robert Guei Amoussan from the Republic of Sierra Leone. I managed to escape to this country (Ivory Coast) where my late father bank offshore because of his political ambition, I came through the help of the International Rescue Committee (IRC). Before my late father died finally in the royal cross hospital he drew my attention to one of his access with a prime bank here in Ivory Coast with some large deposit amount of \$9,000,000.00 US dollars which he smuggled out during his tenure in government before the start of the war, My father told me that he deposited these funds under business incorporated with my name as the next of kin through the help of his foreign partners, he also gave me the certificate of deposit and some other papers issued to him by the finance company, which I still have in my possession.

The only thing holding me here in this country is to have access to my inheritance transferred overseas, the life inside refugee camp is not easy, it a very bad situation, hence

the British Government and UN is not really taking care of me. I have make necessary arrangement legitimately with the bank management for the transfer of the funds out of Africa, only what I need is someone who will receive it in abroad that is why I contact you. I intend to invest the money on a good business, at the same time we will use part to assist the orphanage Child who are suffering, most especially we the refugees. I will be looking forward to hear from you, as I believe that destiny has brought us together. I am in a sincere desire of your humble assistance in this regards. Your suggestions and ideas
